

Galvanize Websites Terms of Use

IMPORTANT – Please read these Terms of Use carefully as they are a binding agreement between you and ACL Services Ltd./dba Galvanize (“Galvanize”).

Galvanize owns and operates the “wegalvanize.com” and associated websites, including the websites referred to as Community, Academy, ScriptHub and Inspirations (the “**Galvanize Websites**”). By accessing, browsing or using any part of the Galvanize Websites, you accept these Terms of Use and agree to be bound by them. If you do not agree with these Terms of Use, you may not use the Galvanize Websites.

Purpose of these Terms of Use

Galvanize has established these Terms of Use in order to:

- Protect the integrity of the Galvanize Websites for all users of the Galvanize Websites;
- Ensure responsible use of the Galvanize Websites;
- Ensure compliance with applicable laws; and
- Protect Galvanize’s intellectual property.

General Use of the Galvanize Websites

User Registration

Galvanize Products
